

MOBILE PANTRY DISTRIBUTIONS OCCUR 20 TIMES WITHIN A MONTH AT EIGHT DIFFERENT LINCOLN LOCATIONS. RURAL MOBILE PANTRY DISTRIBUTIONS TAKE PLACE MONTHLY IN 15 COUNTIES.
