Volunteering at a Food Bank distribution was insightful for Spreetail employee Kelly Kruse, who placed frozen chicken into vehicles for 548 guests on a Friday afternoon in late July.

#### "The number of cars that drive though is such an eyeopening experience ... the need is clearly there," she said.

Kelly and the team at Spreetail are committed to giving back. In fact, the mission to alleviate hunger aligns with the e-commerce company's pillars of giving: helping women in need, helping children in need and helping people experiencing homelessness. This past June and July, volunteer groups from Spreetail helped distribute food on Friday afternoons at the former Perkins Restaurant near the Lincoln Airport — the Food Bank's largest distribution. During this time, these volunteers helped connect 3,645 households with food and hope, including 548 the day Kelly joined.

But Spreetail's efforts didn't stop there. As Kelly explains, "Giving has always been a priority of Spreetail's ... it was clear to me early on the Food Bank was an important partnership." So, this fall, the company launched a campaign to support both Food Bank of Lincoln and Food Bank for the Heartland.

Financial support for Food Bank of Lincoln is making about 450,000 meals possible for neighbors in Southeast Nebraska, primarily children. Additionally, the organization designated the Food Bank as its top volunteering priority, dedicating time to help get food to people facing hunger, a win-win-win for all. "It's such a fulfilling experience for volunteers," Kelly said. "The hands-on and face-to-face interaction with those you are giving to is something volunteering with the Food Bank provides, and that's hard to find right now. Everyone can relate in some way to feeling passionate about serving at the Food Bank."












**Expenses by Program**

## Staff Spotlight and Farewell: Nancy Gritz

Nancy Gritz remembers thinking, "This will be a good place to work for 3-4 years."

That was almost 31 years ago.

In February 1991, Nancy joined the Food Bank of Lincoln as the office and distribution assistant. As one of only six employees, this role had her doing a little bit of everything — reception, record-keeping, checking agencies in and out, weighing food by hand, calling donors, scheduling volunteers and marketing. You name it.

In 1997, when the Food Bank moved from its 7,000 square-foot facility on Russell Drive to our existing location, she added warehouse administrative work, promotions and agency oversight to that list.

"I was always asking if there's something else I could be trained to do, to learn the different areas of the work," she said.

In 2001, Nancy became assistant executive director, taking on much of the financial, human resources and technology work for the Food Bank, a focus she continues today in her role as Vice President of Finance & Human Resources. "I like being busy," Nancy often says. And she is.

But at the end of 2021, after almost 31 years with the organization, Nancy will retire.

"I'll be here almost half of my life ... I've never regretted it. The people I worked with were a piece of that. And really truly, the mission. I love and appreciate what we do. I'm very thankful for all of the people I've gotten to know and things I've gotten to do."



## Raising Our Response to Hunger

Walls are up, concrete has been poured, offices are framed and wiring is underway at 1221 Kingbird Road in Lincoln, Nebraska, the home of the future Food Bank of Lincoln headquarters. At the current Food Bank location, activity is divided between two buildings one that houses general operations and the other, Child Hunger Programs. With expected completion of the new facility on track for spring 2022, Kati Umberger, Youth & Senior Programs Manager and Raising Our Response Project Team Leader, shares what it will mean to have the entire organization under one roof:

"There is no denying the excitement we share as we look forward to occupying the same building. The change in layout will have a positive impact on communication and operational efficiencies, primarily as a major timesaver, improving everything from running product inventories to receiving and loading product from trucks. We anticipate a boost to morale and team dynamics as a result of this upgrade."
